



# **Certifying documents**

The TRBWA will only accept documentary evidence that is in the form of **certified copies of original documents. Original documents will not be accepted. Additionally, faxes, emailed documents and copies of certified copies will not be accepted.** The TRBWA, however, may at any time, require the original documents to be supplied.

A document can only be certified by an authorised witness. An authorised witness is a person that appears on the list of people who can certify documents and is currently employed as, registered and/or licensed to practise in Australia. For example, a doctor who is registered to practise medicine in Australia can certify your documentation, but a doctor who is not registered in Australia cannot.

**If you are currently outside of Australia**, you may be able to find an authorised witness at your nearest Australian Embassy, High Commission or Consulate. Contact details are available on the Department of Foreign Affairs and Trade website <u>dfat.gov.au</u>. Please note that engaging an authorised witness overseas may attract a fee under the Consular Fees Act 1955.

No person under the age of 18 years of age may certify documents.

- Agent of the Australian Postal Corporation who is in charge of an office supplying postal
- services to the public

Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the *Consular Fees Act 1955*)

- Bank manager
- Bank officer with 5 or more continuous years of service
- Building society officer with 5 or more years of continuous service
- Chartered secretary, governance advisor or risk manager
- Chemist
- Chief executive officer of a Commonwealth court
- Chiropractor
- Clerk of a court
- Commissioner for Affidavits
- Commissioner for Declarations
- Company auditor or liquidator
- Court officer
- Credit union officer with 5 or more years of continuous service

Dentist

Electorate officer or a member of State Parliament

Employee of the Australian Trade Commission who is:

- (a) in a country or place outside Australia; and
- (b) authorised under paragraph 3
- (c) of the Consular Fees Act 1955; and
- (d) exercising his or her function in that place

Employee of the Commonwealth who is:

- (a) In a country or place outside Australia; and
- (b) Authorised under paragraph 3 (c) of the *Consular Fees Act 1955;* and
- (c) exercising his or her function in that place

Permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public

- (c) a local government authority; with 5 or more years of continuous service who is not specified in another item in this Part

Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made

Senior Executive Service employee of:
